MASTER OF SCIENCE PROGRAMME REQUIREMENTS

a) Admission Requirements:

- i) The applicant should possess:
 - A Bachelor's degree in relevant field with a minimum CGPA of 2.750; or
 - A Bachelor's degree or equivalent with range CGPA of 2.500 to CGPA 2.749 must have a minimum of three (3) years of working experience in a relevant field or subject to a rigorous internal assessment by the Faculty/Institute; or
 - A Bachelor's degree or equivalent with below CGPA of 2.500 must have a minimum of five (5) years of working experience in the relevant field.
- ii) An applicant who is in the final semester of his Bachelor study programme may be considered for a provisional admission provided that his latest CGPA or its equivalent to academic result satisfies the postgraduate programme admission requirements.

b) Credit Requirements:

- Master candidates are required to complete six (6) credit hours of coursework.
- Candidates must take:
 - i) Master Research (SPS5999) (every semester).
 - ii) Research Methodology or any Research Method course such as Research Method and Design; or Social Statistics (in compulsory, elective or audit status).
 - iii) One (1) credit hour Seminar (Research Proposal) (SPS5903).

^{*} Pass mark 65% and above (grade B)

c) Nomination of Supervisory Committee:

- Nomination can be made starting at the end of the first semester and before the end of second semester using form GS-10a.
- The supervisory committee should comprise a chairman and at least one (1) other member.
- Failure to nominate the supervisory committee by second semester will lead to a SUSPENDED status.

d) Publication Requirements:

Comply with the minimum publication requirement (refer Graduation Requirements [Part 11(57) - Universiti Putra Malaysia (Graduate Studies) Rules 2003).

e) Thesis:

- Master students are required to register for Master Research (SPS5999) as partial fulfillment of the programme. This course is a research project that will be undertaken by the students under the supervision of a supervisory committee.
- Student are encouraged to write their thesis in English.
- Student must give a Notice of Thesis Submission (GS-14a) at least three (3) months in advance.
- The thesis will be evaluated and a viva voce will be carried out to determine students' competence in their chosen field of study.

PH.D DEGREE PROGRAMME REQUIREMENTS

a) Admission Requirements:

- i) The applicant should possess:
 - A Master's degree by research in a relevant field; or
 - A Master's degree by coursework in a relevant field with a minimum CGPA of 3.000; or
 - An outstanding Bachelor's degree with a minimum CGPA of 3.750 or equivalent to the first degree. (Starting First Semester 2018/2019)
- ii) An applicant who is in the final semester of his Master study programme may be considered for a provisional admission provided that his latest CGPA or its equivalent to academic result satisfies the postgraduate programme admission requirements.

b) Credit Requirements:

- PhD candidates are required to complete nine (9) credit hours of coursework.
- Candidates must take:
 - i) Doctoral Research (SPS6999) (every semester).
 - ii) Research Methodology or any Research Method course such as Quantitative Research Method, Qualitative Research Method; or Interpretation of Research Data (in compulsory, elective or audit status).
 - iii) One (1) credit hour Seminar (Research Proposal) (SPS6903).
 - * Pass mark 65% and above (grade B). Students who have already taken the Research Methodology or related courses are eligible for exemption.

c) Nomination of Supervisory Committee:

- Nomination can be made starting at the end of the first semester and before the end of second semester using form GS-10a.
- The supervisory committee should comprise a chairman and at least two (2) other members.
- Failure to nominate the supervisory committee by second semester will lead to a SUSPENDED status.

d) Comprehensive Examination:

All doctoral candidates must take their Comprehensive Examinations (CE) not later than fourth (4th) semester (candidates are only allowed to sit for CE after they passed Seminar (Research Proposal) (SPS6903)).

- The CE shall consist of both written and oral examination and candidates are required to pass both examination.
- · Candidates are not permitted to take the oral examination until they have passed the written examination.

e) Publication Requirements:

Comply with the minimum publication requirement (refer Graduation Requirements.

f) Thesis:

- Doctoral candidates are required to register for PhD Research (SPS6999) as partial fulfillment of the programme. This is a research project that will be undertaken by candidates under the supervision of a supervisory committee.
- Student are encouraged to write their thesis in English.
- Student must give a Notice of Thesis Submission (GS-14a) at least three (3) months in advance.
- The thesis will be evaluated and a viva voce will be carried out to determine students' competence in their chosen field of study.

GRADUATION REQUIREMENTS

i) All students in degree programmes by research must show proof of having published or submitted journal articles (as the first/corresponding author) based on research conducted during their candidature prior to graduation as follows:


