Short Bio:

Dr Muslihah Hasbullah has graduated from the International Islamic University of Malaysia (IIUM) with a degree in LLB (Hons), Master in Comparative Law and Ph.D. in Law. She is now serving as a Senior Lecturer at the Faculty of Human Ecology, Universiti Putra Malaysia (UPM). With an expertise in the field of family law, she teaches Social Policy and Law since 2010 (a core subject in the Bachelor of Human Development Science). She also teaches Child and Family Advocacy as an elective subject in the same program of study. In both subjects she uses the approach of critically examine a variety of social issues, the existing policies, legal remedies and the evaluation of the role of law as a mechanism of social control and social change. She has led several researches related to women and families in Malaysia by using the sociolegal approach specifically on the issues of financial supports, divorce, domestic violence and legal socialization. Her research interests are on family studies and child and family advocacy.

Muslihah has experienced as a consultant researcher in the policy making process at the country and university levels. Her involvement in several Malaysian government-funded consultancy projects (such as KEMAS, IYRES & LPPKN) were to assess program effectiveness and quality of service. In the Quality Services of the Government's Pre-schools' Project (2018-2019) her research team has contributed to the establishment of a 10-year Strategic Plan on Quality Services for Malaysian Early Childhood Education Program. Muslihah is a co-researcher in other policy related projects such as Family Impact Assessment (2020-2022) and a UNICEF family intervention project (Parenting for Lifelong Health - e-PLH) (2020-2022). She has also contributed in the development of Guidelines for Protection Against Sexual Exploitation and Abuse (PSEA) for Universiti Putra Malaysia (UPM) (2021-2022). Currently, she is a co researcher in the Global Parenting Initiative Project (2022-2025) in collaboration with the University of Oxford and funded by the Lego Foundation. She is also a consultant for the MAESTRAL International to provide technical support in the development of the Malaysia National Child Policy and Action Plan (2021-2022) in collaboration with UNICEF and the Ministry of Women Family and Community Development Malaysia (MOWFCD).

Among her publications can be found in social science and legal journals including Scopus, ERA and noncited journals. Throughout her career, she has contributed to the writing of book chapters relating to family and human development and became an editor for book publishing. Her edited book entitled Wanita dan Pembangunan Manusia (Women and Human Development) has been published in 2018 by the UPM's Publisher, which she has used the socio-legal approach in examining women's issues and evaluating policies related to women. In addition, Muslihah also involved in the review of manuscripts for the publication of journals and seminar proceedings local and abroad. Besides, she has several years' experience as a Program Coordinator for Bachelor and Diploma Programs (In campus and Distance Learning Programs) at the Faculty of Human Ecology UPM. Muslihah is also an active member in various working committees in the UPM and involved in the students' mobility programs and industrial trainings internationally and locally. She has led one of the UPM high-impact community networking projects (JESKI 3) in Redang Island, Terengganu (2015-2016) and RedangJuniors@UPM. Her other community project was a collaborative effort with Persatuan Alumni Kolej Islam, Klang (ALKIS) which was held in Langkawi Island (2018).
